SALES AGREEMENT & UNDERTAKING

- Whereas the vendor has agreed to sell and the purchaser has agreed to buy all that ______ plot (s) of land in KEY HAVEN PHASE
 3, Oke Ado Igbonla, Epe, Lagos State, Nigeria.
- 2. Purchaser who make complete payments shall have their plots within the KEY HEAVEN PHASE 3 estate, Oke Ado, Igbonla, Epe, Lagos Nigeria.
- 3. Instalment Payment Terms
 - 55% 60% Initial deposit and spread balance
 - Equal monthly instalments
- 4. Ancillary Fees:
 - a. Survey and Documentation Fee the sum of N250,000 (Two Hundred and Fifty Thousand Naira) is required and payable per plot (subject to review) which is expected to be paid monthly in maximum of three installments. This should be paid before the physical allocation of the land.
 - b. Developmental/Infrastructural Fee: the sum of N350,000 (Three Hundred and Fifty Thousand Naira) is required and payable per plot (subject to review). This can be paid monthly and in three months.
